The Chairman, Senior Procurement Committee (SPC), on behalf of Central Engineering Services (Private) Limited now invites sealed Bids from eligible and qualified local Bidders for Supply, Installation, Configuration and Testing of Audio Visual System for Smart Class Rooms and Boardroom at the proposed FMSH Building at KDU, Ratmalana.

Estimated value of Contract is Rs. 25 million. The Intended Completion Date of the Works is 60 days from the Start Date.

2. Bidding will be conducted through National Competitive Bidding procedure.
3. To be eligible for the Contract Award, the successful Bidder shall not have been blacklisted and shall meet the following requirements:
 - Bidder shall have CIDA Registration Grade EM 2 or above under the Specialty in Extra Low Voltage Installations (ELV)
 - Bidder shall possess a valid Certificate issued by the Registrar of Public Contracts in accordance with the Public Contracts Act No. 3 of 1987.
4. Qualification requirements to qualify for the Contract Award include:
 - Successful completion of at least 02 ELV work in similar nature and complexity for not less than Rs. 25 million each completed during the last five years
 - Average annual value of supply and installation of Audio Visual System work performed in the last five (05) years shall be at least Rs. 40 million.
 - The minimum amount of liquid assets and/or credit facilities required is Rs. 10 million.

Bids shall be delivered and deposited in the Tender Box provided for at the Office of the Chief Operation Engineer (C&SD), 6th Floor, Central Engineering Services (Private) Limited, No. 415, Bauddhaloka Mawatha, Colombo 7 at or before 1400 hrs. on 11.02.2022. Late bids will be rejected. Bids will be opened soon after closing in the presence of Bidders' representatives who choose to attend.
8. Bids shall be valid up to 91 days from the date of closing of Bids.
9. All bids shall be accompanied by a "Bid Security" of Rs. 300,000.00, valid up to 119 days from the date of closing of bids.
10. A Pre-Bid Meeting will be held at 1000 hrs. on 28.01.2022 at the Site of the Proposed FMSH Building at KDU, Ratmalana.
